1. PROJECT OBJECTIVES FOR THE PERIOD

IWWA Coordination Action started on 1st June 2010 and since then, the consortium has worked towards the achievement of the project objectives, which are listed bellow:

General objectives of the IWWA initiative:

- To strengthen the institutional framework for Solid Waste Management and coordination at all levels
- Empowerment of authorities and relevant stakeholders (including private sector) for planning and management of solid waste.
- Encouraging technology transfer, know-how and best practices
- Strengthening links among local authorities
- Promoting participation, public awareness and stakeholder involvement
- Strengthening of the legal framework of SWM in the targeted countries.

Specific objectives:

- To collect and analyze relevant information that is required for proper Solid Waste Management planning and decision-making;
- To identify the stakeholders and their strategies, their interaction and their contribution to the improvement of the solid waste management.
- To identify policy and technology options for SWM adapted to the regional situation of the targeted countries.
- To develop tools for implementation of adapted action plans and systems by the regional and national authorities.
- To provide training for environmental specialists, increase the environmental awareness of the public and bring about effective public participation in Solid Waste Management

2. WORK PROGRESS AND ACHIEVEMENTS DURING THE PERIOD

2.1 Work packages progress summary

In this section an overview of the actions carried out in the last 6 months of the project (June 2011-October 2011) of the project is provided, based in the work packages active during these months. During the last 6 months of IWWA project, 4 work packages have had active tasks: WP4, WP5, WP6 and WP7. On the other hand, work packages WP1, WP2 and WP3 have been already completed during the first year of the project (only D3.3 was delayed (10 days) and was submitted in month 13, however it was reported in the first periodic report since its submission occurred during the preparation of the report).

2.2 Description of work packages progress

Work Package 4: Elaboration of Policy guidelines and recommendations (WP leader ELRI)

Task 4.1: Elaboration of guidelines for the future implementation of strategies:

Task leader OEKO

Other participating partners: TTZ, BIOAZUL, SLU, GAIKER, TUB, ENDA, MATAM, IAGU, ZOOM, CEIA, KNUST, BCRC, ELRI, UAA, CEDARE and ICANDO.

Task 4.1 has been completed during the last 6 months of the project. Its main outcomes have been Deliverables 4.1 and 4.2.

Deliverable 4.1 has set the principles on which best policy options subsequently described in task 4.2 are based. It starts from the barriers and obstacles to waste management identified in Task 2.5 and described in Deliverable 2.1, and highlight the best policy measures to adopt in the 4 target countries.

The best policy options evaluated are the realization of coherent ISWM legal frameworks in the target countries and their enforcement by a coherent organizational structure, by an innovative relation between local authorities and the policy environment, by an implementation through public participation, by adequate funding concepts, by the improvement of personnel know-how at the technological and organizational level, by suitable waste characterization & data on collected and recovered waste, by the implementation of the existing informal sectors for future reliable waste collection service and waste segregation and by innovative strategies for the securing of the land availability for landfills and the addressing of transport problems to landfills.

Deliverable 4.2 is based on the outcomes of deliverable 4.1 regarding the recommendations for policy measures in the target countries, the report presents methods for the future implementation of policy strategies in ISWM. The guideline will support authorities in the inclusion of participatory approaches for future ISWM strategies. The guideline outlined in this report is structured by

- Principles to develop a roadmap for ISWM (chapter 2),
- Definition of goals, stopovers & deadlines for a roadmap (chapter 3),
- Definition of responsibilities for the development of a roadmap (chapter 4),
- Principles to enable effective participation of stakeholders in policy setting and implementation (chapter 5),
- Best practices to monitor the implementation of the roadmap (chapter 6) and
- Role of the stakeholders in the target countries (chapter 7).

Task 4.2: Elaboration of policy briefs for the development of National and Regional Action Plans in each target country

Task leader ELRI

Other participating partners: TTZ, BIOAZUL, EMPA, SLU, GAIKER, TUB, ENDA, MATAM, IAGU, ZOOM, CEIA, KNUST, BCRC, UAA, CEDARE and ICANDO.

Task 4.2 has been completed in the last 6 months of the project. The main outcome has been Deliverable 4.3. The aim of this report (Deliverable 4.3) is to outline the policy briefs for the development of National and Regional ISWM Action Plans for the target countries based on the analysis of the EU policy options discussed in previous deliverables. The outlined policy briefs are meant to address the peculiar ISWM needs of the target regions and establish measures for institutional support, coordination amongst key role-players, emphasise stakeholder participation and also address the capacity needs of the stakeholders.

In this document, Chapter I introduces the aims and objectives of the ISWM action plans that will implement the policy briefs for the target countries. The policy briefs are outlined in Chapter 2 and are based on the barriers identified from previous reports (D2.1 and D4.1). These policy briefs are meant to address the ISWM needs of the target regions and establish policy options that are applicable. Chapter 3 focuses on the stakeholders roles throughout the implementation of the applicable policies and proper coordination amongst them. Chapter 4 addresses the capacity needs of the stakeholders, while Chapter 5 further expands on recommendations for policies and measures that need to be implemented

Deliverable 4.3 was intended to set the basis for ISWM action plans in the target countries and is not intended to provide an exhaustive list of everything that should be done. Thus, it focuses on those strategies and priority initiatives that require a national approach and those that involve collaboration amongst jurisdictions. Individual jurisdictions will continue to manage waste in line with their strategic objectives and constitutional responsibilities. It is intended that this implementation plan is a living document that is regularly updated as initiatives are scoped, consultation occurs, details on timing and nature of initiatives are developed, and initiatives are completed.

Work package 5: Evaluation of the implication of proposed changes (WP leader: BCRC)

Task 5.1: Prognosis on environmental and socio-economic effects in the target regions

Task leaders: BCRC and CEIA

Other participating partners: BIOAZUL, EMPA, SLU, OEKO, GAIKER, TUB, ENDA, MATAM, ZOOM, CEDARE and ICANDO.

Task 5.1 started in month 18 and is still in progress. BCRC as task leader has drawn up a work schedule for the task and circulated it among the partners. The work commenced with drafting up the contents of the report on environmental effects of the proposed changes. Responsibilities/ tasks and timelines were assigned to all partners involved to ensure submission on time. Section 1 of

Deliverable 5.1 (prognosis on environmental effects) has been already completed. Currently contributions from partners regarding socio-economic effects are being collated. It is not initially expected any delay in the submission of Deliverable 5.1 to the EC due to month 20 (January 2012).

Task 5.2: Evaluation of the proposed measures in the Region of Matam (Senegal)

Task leader: MATAM

Other participating partners: ENDA

For this task, some preparatory meetings were already organized at the regional council, and a list of potential participants is being elaborated by ENDA and MATAM. The content of the one day session has not been developed yet, since inputs from task 5.1 are needed. ENDA and MATAM will develop the agenda and contents in the following weeks.

Work package 6: Dissemination and Training (WP leader: CEIA)

Task 6.1: Participatory workshops for relevant stakeholders

Task leader: CEIA

Other participating partners: ENDA, KNUST, BCRC, and UAA

This task was completed during the first year of the project with the exception of the workshop in Ivory Coast which was postponed due to the political crisis and which was organized in month 13 of the project.

Task 6.2: Capacity building of stakeholders for future implementation

This task started in month 8, and is still in progress.

4 workshops for capacity building of relevant stakeholders are foreseen in the DoW for the target countries (one seminar in each country). The seminars have been scheduled as follows:

- Month 17: Workshop in Nigeria organized by ELRI
- Month 18: Workshop in Ghana organized by KNUST
- Month 18: Workshop in Ivory Coast organized by UAA
- Month 19: Workshop in Senegal organized by IAGU

The workshop in Nigeria was carried out in month 17 (October 2011) as foreseen. Workshops in Ghana, Senegal and Ivory Coast have not been organized yet due to some logistic constraints which obliged to postpone the events a few weeks. These three workshops are expected to be held in months 19 and 20 respectively. Thus, a possible small deviation in the submission of Deliverable 6.4 could be expected since the task leader would require at least one week to collect all the information from the organizers of the workshops and to summarize it in the report.

Task 6.3: Development of tools and activities for mass dissemination

Sub-task 6.3.1: Webpage establishment (set-up and service):

The project webpage www.iwwa.eu has been established in month 3 of the project as foreseen in the DoW. It enables widespread dissemination of the project, its objectives, results, beneficiaries and ISWMS in general. The page has been continuously updated providing all events and achieved results. All reports, annexes and deliverables which have been submitted and approved by the European Commission as well as any other relevant material are available in the password protected area for the project partners and the EC. Public deliverables (according to the DoW) are also available in the public area of the website.

Sub-task 6.3.2: Production and dissemination of project promotional leaflets and Poster





4. PROJECT MANAGEMENT

General project management (task 7.1):

After the mid-term meeting held in Dakar (Senegal) the First Periodic Report was submitted according to the DoW. After the successful completion of the periodic period a payment to all partners was initialized. All deliverables and reports from WP4 have been submitted on time and the upcoming ones from WP5 are expected to be finalized within the given deadlines. Only Deliverables 6.8 (second promotional leaflet) and 7.3 (current report) are being delayed due to organizational reasons. Following a request from the EC officer the already submitted reports of WP1 and WP2 had to be revised and amended accordingly. This amendment was also completed and the deliverables were successfully submitted back to the EC together with the submission of the Periodic Report.

Based on request of the majority of the project partners the Final meeting/conference of the project in month 22 in Accra, Ghana was re-scheduled. This was done with the approval of the EC officer. The final meeting/conference of the project will be held in month 24 in Accra, Ghana. TTZ is supporting ZOOM in the organization of the event and preparations have already been started. Due to this shift also the second leaflet and poster of the project will be a bit delayed as the consortium wants to have all details included.

Following the settlement of the dispute between the United Nations and the European Commission, it was requested by the EC officer that the United Nations University becomes a third party in the project. For this reason a second amendment to the contract was made where UNU was officially included. The allocated budget was included as part of the coordinator's budget and will be paid after completion of tasks as foreseen in the DoW. Furthermore, a shift of man-months between partners ENDA, MATAM and IAGU was necessary due to the fact that in WP2 and WP3 some of the tasks allocated to MATAM were completed by IAGU and ENDA. All other provisions and clauses of the contract remained without any change.

TTZ, as project coordinator, has been invited by the European Commission for external evaluation of the project in the beginning of 2012 in Brussels, Belgium. The exact date and time are still to be decided.

Regional project management (task 7.2):

The Regional Coordinator, ZOOM, has been in touch with the other coordinators and the beneficiaries during the whole reporting period. They have acted as a contact point for all African partners and supported and controlled all project activities in the region. They have also monitored the overall work progress and flow to ensure timely completion of activities. When necessary ZOOM worked closely with TTZ and BIOAZUL in order to solve any problem with regards to timely completion of activities and suggest measures to overcome time overrun.

Administrative management (task 7.3):

As Administrative Coordinator, BIOAZUL was the beneficiary in charge of requesting all necessary information to prepare the project reports and record all costs incurred by the project participants. In order to do this properly, BIOAZUL prepared and distributed on due time all necessary templates and guidance documents among the consortium members, in order to ensure the correct recording of the activities performed and the resources used during this first project period. This information was periodically requested to the project beneficiaries during the period, in order to check that all beneficiaries were using their resources properly and to avoid any unnecessary spending.

Besides, BIOAZUL prepared a guideline for the partners to register and fill in their Forms C on the FORCE platform, which was presented during the Mid-term meeting and sent to all partners in advance. BIOAZUL has been in permanent contact with all project beneficiaries in order to assess them regarding FORCE use during the reports preparation stage.
